## SALES REPRESENTATIVE AGREEMENT

(Updated May 15, 2020)

Agreement between \_\_\_\_\_ (Company) and CHS Snowmakers Inc.  
(Sales Representative).

### CHS Snowmakers agrees:

1. To represent and sell the Company's products, specifically described as \_\_\_\_\_ in the geographic area of world-wide.
2. To list items with description, condition, any recent repairs, any items that need repair, asking price and four photos on CHS Snowmakers' website. Listing expires after 1 year of date on this contract.
3. To maintain contact with the Company via telephone, e-mail, or other agreed upon means of communication, with reasonable frequency, to discuss sales activity of items listed above.
4. To return promptly all materials and samples provided by the Company to the Sales Representative, if either party terminates this agreement.

### The Company agrees:

1. To pay the following commissions to the Sales Representative:
  - a. Five percent if the Company collects the funds, ten percent if the Sales Representative collects the funds, including a \$20 per item listing fee paid up front. Listing fee is non-refundable.
2. To negotiate in advance of sale, the minimum sales price for items listed above \$\_\_\_\_\_
3. That they are the rightful owner and/or have the rights to sell the listed equipment.
4. If the item sells through other means, the Company will provide to the Sales Representative the buyer's name and location to verify the buyer didn't contact the Sales Representative. If the Company doesn't provide this information, CHS Snowmakers will invoice Company 5% of the listing price.

### In addition, both Parties agree to one of the following (CHECK ONE BOX):

- CHS Snowmakers collects funds and pays company sale price, minus 10% commission, within 30 days (no cap on commission), this includes items listed on the auction website.
- Company collects funds and pays CHS Snowmakers 5% commissions, within 30 days of final payment, cap of \$10,000 for commission.

This constitutes the entire agreement.

This agreement shall be binding upon the parties and their successors and assigns.
